

## ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

(Notice under section 18)

DEVELOPMENT OF ANDERSON ROAD QUARRY SITE—  
ROAD IMPROVEMENT WORKS—PACKAGE 2

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing at grade carriageways, elevated carriageway, at grade footpaths, elevated footpaths and central reserves/refuge islands within the limit of works area as shown on Plan No. 60328348/GAZ\_RIW/131 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 2784 published on 20 May 2016 and 27 May 2016. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that from 21 January 2022 to 20 January 2023, all public or private rights in, upon, under or over the sections of the existing at grade carriageways, elevated carriageway, at grade footpaths, elevated footpaths and central reserves/refuge islands to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve construction of an elevated carriageway connecting Lin Tak Road and Sau Mau Ping Road and associated junction/road modification works, modification and realignment of sections of the existing slip roads connecting Tseung Kwan O Road and Sau Mau Ping Road, modification and realignment of a section of the existing slip road connecting Tseung Kwan O Road and Lin Tak Road, modification and realignment of a section of the existing Lin Tak Road, modification of the existing junction at Lin Tak Road/Pik Wan Road, construction of carriageways, footpaths, central reserves/refuge islands, semi-enclosure, noise barriers, and other ancillary works.

This notice will be affixed on or near the affected at grade carriageways, elevated carriageway, at grade footpaths, elevated footpaths and central reserves/refuge islands on 7 January 2022.

Any person entitled to compensation under the Ordinance may serve upon the Secretary for Transport and Housing a written claim, which can be submitted *via* one of the following means, before the expiration of one year from the date of closure, extinction, modification or restriction:—
